Please read, sign, and bring with you to Conference. Your parents must sign if you are under 18 years of age. The signed form is required at registration.

- 1. No alcoholic beverages allowed.
- 2. No drugs, unless prescribed by your doctor. Let the Conference Coordinator know if you will be taking any medication during the week.
- 3. A deposit of \$150 is required by June 15, 2019. The balance of the Conference fee (\$125) is to be paid prior to or at registration (July 21).
- 4. No one is to leave the Conference before its conclusion, without Board approval. If anyone does choose to leave, they will not receive a refund on their Conference fee.
- 5. All those registered as Conference participants will be required to attend all rehearsals, activities, and/or outings. Sickness only is excused, and then must be cleared through the Conference Coordinator, or a Board member.
- 6. There will be no loud music or noise at the hotel. Please respect the other guests.
- 7. All meals are required. You need a balanced diet to keep your energy up throughout the Conference.
- 8. No one is to leave the Conference premises (rehearsal space, hotel, wherever we are as a group, at any given time) without permission from the Conference Coordinator, or a Board member.
- 9. There will be no overnight visitors at Conference. All visitors must leave at the end of each day's activities.
- 10. Everyone is to be in his/her room with the lights out, at the time specified on the schedule. There will be room checks! Lights out also means quiet please be courteous to those in the rooms around you.
- 11. All rooms are to be kept neat. There is time allotted each morning to clean rooms, so the hotel maintenance people can make beds and freshen bathrooms.
- 12. Any damage to hotel rooms, rehearsal spaces, etc., is the responsibility of the member or members involved. You and PII are liable for damages to any Conference facilities. Please don't do anything to disgrace the organization.
- 13. Smoking is permitted in designated areas only. PII will adhere to the smoking laws set forth by the State in which we are attending Conference. The band is allowed to smoke sweet solos at any and all times.
- 14. Shoes must be worn during all performances.
- 15. The Board of Directors reserves the right to conduct room searches when deemed necessary. The Board of Directors and the Disciplinary Committee will take disciplinary action against anyone disobeying Conference rules. The disciplinary action taken will depend on the severity of the infraction. The Board of Directors reserves the right to send anyone home at their or their parent's / guardian's expense, for serious and/or repeated infractions. Anyone dismissed from Conference for disciplinary reasons is not entitled to a refund of their Conference fee.
