



CONFERENCE 2025 RULES AND EXPECTATIONS

Please read, sign, and bring with you to Conference. Your parents must sign if you are under 18 years of age. The signed form is required at registration.

- 1. Prohibited Substances** - No alcoholic beverages or illegal drugs allowed.
- 2. Prescription Medications** - No drugs, unless prescribed by your doctor. This includes the legal use of medical marijuana in any form. Prescription drugs should always be kept in their original labeled packaging.
- 3. Payment Requirements** - A deposit of \$250 is required by May 25, 2025. The balance of the Conference fee (\$250) is to be paid prior to or at registration.
- 4. Remaining on Premises** - Do not leave the Conference premises (rehearsal space, lodging space, group activities, etc.) at any given time without approval of a Board Member or the Conference Coordinator. Pii is not responsible for your safety outside of the Conference premises.
- 5. Early Departure Notification** - If you need to leave Conference before its conclusion, you must notify the Board. If you do choose to leave, you will not receive a refund on the Conference fee.
- 6. Attendance Expectations** - Registered Conference participants must attend all rehearsals, activities, and/or outings, unless they have Board member or Conference Coordinator approval. Failure to attend rehearsals may result in losing performance privileges.
- 7. Noise Restrictions** - There will be no loud music or noise in any lodging spaces.
- 8. Meal Participation and Accommodations** - All meals are required. Let the Conference Coordinator know about any allergies or dietary constraints prior to the week of the conference. **
- 9. Visitor Policy** - Arrangements for long-term visitors must be approved by the Board or Conference Coordinator. There will be no overnight visitors at Conference.
- 10. Curfew/Lights Out** - Everyone is to be in their room, with the lights out, at the time specified on the schedule. Headcounts will be taken by Board Members at lights out. Please be courteous to the people around you.
- 11. Room and Facility Care** - All rooms must be kept neat. Any damage to lodging space, rehearsal spaces, etc., is the responsibility of the members or members involved. You and Pii are liable for damages to any Conference facilities. Please don't do anything that reflects poorly on the group.
- 12. Smoking and Vaping Regulations** - Smoking and/or vaping is permitted in designated areas only. Pii will adhere to the smoking laws set forth by the state in which we are attending Conference. This includes the legal use of medical marijuana and tobacco in any form.
- 13. Footwear Requirement** - Shoes must be worn during all performances and dress rehearsals.

14. Disciplinary Measures - The Board reserves the right to conduct room searches when deemed necessary. The Board will take disciplinary action against anyone disobeying Conference rules. The Board reserves the right to send anyone home at their or their parent's/guardian's expense. Anyone dismissed from Conference for disciplinary reasons is not entitled to a refund of their Conference fee.

*** Coordinators will work with individuals who have dietary restrictions to accommodate their needs as much as possible. However, some dietary needs may not be met when meals are prepared by a third party or if the list of restrictions is extensive. In such cases, participants may need to prepare part or all their meals in a provided kitchen space. Any changes to conference fees will depend on whether the organization receives a discount from the venue.*
